

NTEU elects a President at the National Convention every four years. Ms. Kelley had been elected four times to serve four year terms.

# NTEU73 Needs Volunteers for Legislative Committee

With election time fast approaching, NTEU73 is gearing up its legislative program in an attempt to influence elected officials and Congress in regard to federal employee issues. NTEU takes a leading roll nationally in lobbying Congress and attempting to elect officials who are friendly to the federal workforce.

NTEU73 Legislative Coordinator Debbie Mullikin is asking for volunteers to serve on the local committee.

"We do a lot of different things," Ms. Mullikin said. "Everything from letter writing campaigns, meeting with Congressional members in person to educating the members about which candidates are receptive to our issues."

NTEU73 has been nationally recognized for excellence in lobbying activities and it is a tradition that the chapter is committed to repeating.

"Lately many in Congress have been seemingly opposed to federal employees," continued Ms. Mullikin. "We are constantly under attack on a whole range of issues, not the least of which is our pay, retirement, medical insurance...you name it! I have never seen it like it has been over the last several years. It just seems like many in Congress see no value in the federal workforce. Don't they realize that if we did not do the work, they would have to get some one else to do it? If we are given the proper tools, we can do the job as well as anyone.

"I am looking for volunteers to help with our efforts. All of this work has to be done on your own time and not here at work. But it is vitally important to let Congress know about our issues and educate them about what we do for the country."

NTEU has a national political action

committee (PAC) called TEPAC.
Members can donate money to TEPAC
and that money is used to lobby Congress
and promote candidates that are friendly to
federal workers.

"There are a lot of lobbyists with a lot of money and most are not working for us," explained Ms. Mullikin. "TEPAC helps to level the playing field but much more needs to be done. We need some folks to step up and help. There is a lot to do and the more people who can help, the more we can accomplish."

Since **Rick Riley** took office in April, the union has handled 245 cases for the employees. Two hundred situations were handled informally with the managers. Forty-five grievances have been filed, many were closed favorably, some are still pending.

Here are just a few of the local items stewards have recently resolved:

Will Kohler got an employee priority consideration on the next job opportunity, was able to get an employee moved back to a desk where she gets proper support and got AWOL hours reduced that were charged to an employee!

Ron DuMoulin got an employee's evaluation raised to a 4.6!

**Stacy Rust** was able to get an employee thirty minutes of overtime pay!

Robert Starks got an employee's evaluation raised!

Bill Dreier got a letter removed from an employee's file!

**Daniel McNamara** got an employee's evaluation raised from 3.4 to 4.0! He also got two employees perm positions, helped several more with FMLA issues and removed AWOL for three employees.

**Michelle Robinson** helped an employee receive her higher graded duties pay, helped another employee receive time off under LWOP instead of AWOL and got an employee moved to another area! She also worked with Chief Steward Karen Walsh to have an employee's termination letter changed to a resignation.

# 60 Second Updates

An arbitrator has awarded three grievants the maximum allowable Employee Suggestion Program (ESP) award, \$50,000, for their suggestion that the IRS initially determined did not qualify for an award. Big win for National NTEU!

NTEU is soliciting for qualified bargaining unit employees to serve as subject matter experts regarding content development for select new series 592 CareerConnector questions.

NTEU and the IRS have reached an agreement settling the ULP charge NTEU filed over the agency's unilateral implementation of the Paperless

"Collection Dues Process" Pilot in the Office of Appeals.

The Senate Finance Committee issued a bipartisan report summarizing the committee's findings of its investigation into the IRS's handling of certain tax-exempt status applications. It found that IRS front line employees were not responsible for the recent TEGE debacle involving applications from T-Party organizations. They had been blamed by upper IRS management for the problems.

Data Breach Update: In the courts, NTEU continues to pursue its lawsuit to provide lifetime credit monitoring and identity theft protection for members and to prevent such attacks in the future.

#### **Key Congressional Bills to Watch!**

2015 House (H. Con. Res. 32, Price-GA) and Senate (S. Con. Res. 11, Enzi-WY) passed budgets-disproportionately target federal employee benefit programs, resulting in significantly higher retirement and health care employee contributions;

including requiring current employees to contribute approximately 6% more of salaries toward retirement, reducing the value of the TSP's G fund, and eliminating the FERS Supplement NTEU OPPOSES!

H.R. 1230 (Rep. Westerman-AR)-reduces federal pensions by basing annuity calculations on high-5 versus the current high-3 formula. NTEU OPPOSES!

H.R. 785 (Rep. Edwards-MD)-rolls back the increased employee retirement contributions for federal workers hired since 2013. NTEU SUPPORTS!

H.R. 138 (Rep. Issa-CA)-opens up the Federal Employees Health Benefits Program to individuals outside the federal community. NTEU OPPOSES!
